Safety of β -lactoglobulin as a novel food pursuant to Regulation (EU) 2015/2283

► Following a request from the European Commission, the EFSA Panel on Nutrition, Novel Foods and Food Allergens (NDA) was asked to deliver an opinion on β -lactoglobulin as a novel pursuant to Regulation (EU) 2015/2283. The novel food is proposed to be used as a food ingredient in isotonic and sport drinks, whey powder and milk-based drinks and similar products, and in food for special medical purposes. The Panel concludes that the novel food is safe under the proposed conditions of use.
