- As part of the follow-up evaluation of locust bean gum (E 410) for its uses as a food additive in foods for infants under 16 weeks belonging to food category 13.1.5.1 (Dietetic foods for Special Medical Purposes and Special Infant Formulas), the Panel on Food Additives and Flavorings concluded that a margin of exposure greater than 1 would not pose a safety concern.
